1. **SUBSTITUTES AND APOLOGIES**

2. **DECLARATIONS OF INTEREST**

7. PLANNING APPLICATIONS

DC/24/04467

Proposal: Notification of works to trees in a conservation area – Proposal to fell Norway Maple (T1), reduce by 2.5-3m to previous pruning points Sweet Chestnut Tree (T2) and reduce and rebalance by 2 metres Mulberry Tree (T3). **Location:** Prospect House, 60 Friars Street, Sudbury, Suffolk, CO10 2AG

RESOLVED – To recommend approval for tress T2 and T3, but recommend refusal for the Norway Maple (T1) until it has been inspected by a Babergh Tree Officer to ascertain the exact species of the tree, whether the tree is causing damage, and if any works are required.

Proposal: Notification of Works to Trees in a Conservation Area – Crown reduce 1No. Magnolia (T1) by 6-8ft. **Location:** Long Walls, 30 Meadow Lane, Sudbury, Suffolk, CO10 2TD

Proposal: Planning Application – Change of Use of Unit 1 to a 24 hour gym within Use Class E.

Location: Unit 1, Shawlands Retail Park, Newton Road, Sudbury, Suffolk, CO10 2BG

RESOLVED - To recommend refusal for the following reasons;

- That the businesses within Shawlands Retail Park are not permitted to open 24-hours a day and this would set a precedent that others could use to extend their opening hours.
- There is insufficient parking available on the near side of the gates which are shut by the Shawlands Management Company during closing hours.
- Opening the gates at night would risk increased antisocial behaviour.
- A large gym would increase traffic congestion at this important junction.

8. TO DISCUSS BABERGH DISTRICT COUNCIL'S OFF-STREET PARKING PLACES ORDER

The members considered Babergh District Council's off-street parking places order 2024 showing current parking charges and the proposed new charges for North Street car park, Girling Street car park, Great Eastern Road, the Station and Station Road car parks.

RESOLVED

To reply to Babergh District Council to ask for clarification on the 5 points below;

- Sudbury Town Council welcome the permits for residents in short stay car parks, but could parking on Saturday afternoons be included in the season tickets for local residents?
- No mention of reimbursement for Roys customers in Great Eastern Road.
- No mention of a restricted return period. Could traders (plumber, electricians, etc) return to the same car park for another job soon after a previous visit?
- Inconsistency for Kingfisher Leisure Centre users, the order says 2 hours free, but a Babergh District Councillor believed that 3 hours free had been agreed.
- No mention of waiving the charges for those attending medical or dental surgeries.

11. TO DISCUSS THE HIGHWAYS LIST

Members discussed the following points;

- Acton Lane blocked drain update to note Cllr J Carter's email from Suffolk Highways explaining the process for cleaning drainage gullies.
- Chaucer Road to Clermont Avenue link road update to note email form Suffolk County Council and request that the police safer neighbourhood team (SNT) to visit and enforce the current Traffic Regulation Order.
- Croft Bridge repairs update to note the email from Suffolk Highways stating that the bridge was safe to use and that there would be further work to stiffen the parapets.
- Newton Road ANPR speeding results to ask that the police safer neighbourhood team (SNT) visit and enforce the speed limit.

Members raised the following concerns;

- Upper East Street pavement parking to ask the police safer neighbour team (SNT) to visit
 the area and assess the problem. Any other possible measures could be discussed at the
 next meeting.
- The bollard at the junction of Burkitts Lane and Gainsborough Street had been hit by a vehicle and damaged. (reported by the Town Clerk to SCC ref:494099)
